The Lower Brule Sioux Tribal Council meeting was held at the Tribal Administration Building on Wednesday September 1, 2021. The meeting was called to order by Chairman Clyde J.R. Estes at 10:06 am.

#### 3. Lower Brule Rural Water

Motion was made by Stephanie Bolman to approve the bid from RDO Equipment to purchase a mini excavator in the amount of \$63,384. This motion was seconded by John McCauley. Motion carried with the vote being five members for, none opposing.

Motion was made by Stephanie Bolman to approve the bid from USA Blue Book to purchase an electric powered valve operator in the amount of \$7,824.70. This motion was seconded by John McCauley.

## 4. Lower Brule Roads Department

Motion was made by John McCauley to approve the bid from Dakota Barricade for the purpose of road striping in the amount of \$56,846. This motion was seconded by Cody Russell. Motion carried with the vote being five members for, none opposing.

#### 5. Lower Brule Head Start

Motion was made by John McCauley to approve the bid from Sharpe Enterprises, Inc for the construction of a multipurpose room in the amount up to \$250,000. This motion was seconded by Cody Russell.

### 6. Programmatic Agreement

Motion was made by John McCauley to approve a Programmatic Agreement among the Bureau of Reclamation, Dakotas Area Office, Lower Brule Sioux Tribe, Lower Brule Sioux Tribe Cultural Resource Officer, Rosebud Sioux Tribe, Rosebud Sioux Tribe Historic Preservation Officer and the South Dakota State Historic Preservation Officer. This motion was seconded by Stephanie Bolman.

Motion carried with the vote being five members for, none opposing.

#### 7. Ring of Fiber

Motion was made by John McCauley to authorize the creation of the Oceti Sakowin Oyate Consortium for the purposes of the NTIA Tribal Broadband Connectivity Grant. This motion was seconded by Stephanie Bolman.

Motion carried with the vote being five members for, none opposing.

#### 8. Lower Brule Cultural Resources

### The 2021 Annual Fair & Powwow

The Powwow Committee has taken all comments, complaints and suggestions under advisement and will work on addressing them and making necessary changes as they begin planning for the 2022 Annual Fair.

The remaining buffalo and cow meat will be distributed to elderly, households on quarantine due to Covid-19 and donated to funerals and wake services.

#### 9. Lower Brule Motor Pool

Motion was made by John McCauley to approve the Lower Brule Motor Pool Program to surplus and auction off nine vehicles. This motion was seconded by Cody Russell. Motion carried with the vote being five members for, none opposing.

#### 10. Lower Brule Indian Health Services

COVID-19 testing is available Monday through Friday. A mini lab has been set up to allow for faster processing. 7,200 COVID-19 tests have been completed; all positive tests are sent off to test for the Delta variant. Moderna & Pfizer vaccines are currently available.

Flu shots are now available at the clinic.

Motion was made by Cody Russell to approve the budget for the 2021 American Rescue Plan (ARP) Funding for the Lower Brule Schools in the amount of \$3.5M. This motion was seconded by Donovan Grassrope.

Motion was made by John McCauley to approve the budget for the 2021 American Rescue Plan (ARP) Funding for a Native Language Program in the amount of \$82,609. This motion was seconded by Donovan Grassrope.

Motion carried with the vote being five members for, none opposing.

Motion was made by Cody Russell to approve raising the per diem rate for student activities from \$12 to \$15 per meal. This motion was seconded by Donovan Grassrope. Motion carried with the vote being five members for, none opposing.

Motion was made by Cody Russell to approve the Lower Brule Superintendant to surplus a 2008 Chevrolet MID bus. This motion was seconded by John McCauley. Motion carried with the vote being five members for, none opposing.

Higher Education will be funding thirty undergraduate students for the fall 2021 semester. Five Adult Vocational Students will be funded under AVT.
