The Lower Brule Sioux Tribal Council meeting was held at the Tribal Administration Building on Wednesday October 7, 2020. The meeting was called to order by Chairman Clyde Estes at 1:55 pm.

# 3. ## 5. Motion to remove former Chairman Boyd Gourneau and former Secretary-Treasurer Orville Langdeau Jr. from signatories list of payroll accounts.

Motion was made by Stephanie Bolman to remove former chairman and former secretary-treasurer from signatories list. This motion was seconded by John McCauley. Motion carried with the vote being five members for, none opposing.

### 6. Address Sandra Byington's letter of request for assistance with plumbing.

John McCauley will follow up and report back. No formal action taken.

## 7. Lower Brule Health Department gave a presentation to council on current covid-19 numbers—Christine Olson, Shirley Crane, Jewel Jandreau.

This program provides everyone in the quarantined homes two meals a day within the Lower Brule Reservation; approximately 1,800 meals served so far. Current covid-19 numbers: 11 active cases; 102 recoveries; 3 deaths; 35 in quarantine.

No formal action taken.

### 8. Golden Buffalo Casino update—Quintin McGhee.

Casino is in Phase 3: Staff does sanitizing of the casino every hour; temperature checks required; machines are cleaned after every use; capacity capped at 50%; rapid testing for covid-19 of staff. Indian Gaming Commission Board of Directors: budget is for certification trainings; no minutes are being taken; 28 internal control findings since January 2020; corrective actions have been taken on four findings with new compliance officer.

Two IRS findings: Title 31 policy and Suspicious Activity and Reporting needs to be addressed as nothing is currently in place and casino could face fines/penalties.

Lower Brule Programs utilizing casino services are not paying invoices; \$31,514.12 unpaid past due bills. New bills since the casino reopened amount to approximately \$12,000 that are unpaid. Excessive damage to the motel has been done by individuals staying during quarantine.

Ketel Thorstenson, LLP replaced ELO as external auditors for the casino.

No formal action taken.

### 9. Tribal Finance Department Cares Act Report—Trish Lundell, Susan Ziegler.

Cares Act amount received \$7,812,569.62 (\$5.8M remaining).

Aid to Tribal Government amount received \$1,047,154.00 (\$104,000 remaining).
