The above named Defendants, and Appellants, Kevin Wright, Sonny Ziegler and Desiree Laroche, having moved for leave to take an Intermediate Lower Brule Sioux Tribal Court of Appeals from a July 9, 2015 Order from Lower Brule Sioux Tribal Court.

The Court finds that this appeal involves a controlling question of law as to which there is substantial grounds for difference of opinion, and an immediate appeal from that order may materially advance the ultimate termination of the litigation and any delay caused by the appeal will not adversely affect the interest of a litigant should the appeal be unsuccessful.

It is therefore Ordered:

1. That the Jurisdiction is granted and that questions are to be reviewed by the Lower Brule Tribal Court of Appeals.
2. That the Clerk of Courts shall prepare a record of all proceedings and documents concerning this case and shall forward them to the Lower Brule Sioux Court of Appeals.

3. IT IS FURTHER ORDERED THAT APPELLANT IS RESPONSIBLE TO ORDER TRANSCRIPTS OF TAPED PROCEEDING OR TAPE. APPELLANTS MAY ASK FOR A WAIVER OF TAPE OR TRANSCRIPT REQUIREMENT IF ALL PARTIES AGREE (IN ACCORDANCE WITH NPICA RULES OF APPELLATE PREOCEDURE RULE 10)
